



## Monthly Business Meeting

The Regular Monthly Business Meeting was held at 6:30 p.m. Bro. Billy Compton served as moderator.

**March 16, 2022**

Bro. Billy Compton called the meeting to order.

The Treasurer's Report was approved as presented by Andrea Morrison. The Embrace Tomorrow Fund is at \$95,375.19, with a total of approximately \$130,000 in all funds given for renovation.

Sunday School: Josh Veatch reports things are going well, with 97 in attendance with the last meeting. The spring literature is in, and there has been a recent volunteer to help teach Sunday School.

Trustees: Don Veatch reported there would be a proposal in New Business concerning the air conditioner in the sanctuary.

Transportation: Sam Graham reported the bus is ready and encourages groups to use it.

Security: Sam Graham reported the group will meet at 6:00 p.m. Thursday, March 24, here at church. They will work on altering the schedule to fit the new Sunday School/Church times. If having an event, and want security, please contact the team.

Vision 24: Josh Veatch reported the group is getting prices/info and will have a proposal in the new future.

Deacons: Mark Carney reported the group met March 2, 2022 with 6 deacons and the pastor present. They discussed upcoming services, insurance coverage, and will meet with an agent soon to see if we have enough coverage. They will meet on Wed, March 30, at 5:45 p.m. April 9<sup>th</sup> has been set as Spring Cleaning Day at Church from 10:00 a.m. – 2:00 p.m. They have no recommendations.

Personnel: Jim Sabo reported they have a prospective music leader. Further consideration will be given after Easter.

Don Veatch reported that the Renovation Committee is getting numbers on playground equipment.

New Business: Don Veatch, upon recommendation of the Trustees, made a motion that we hire Johnny Rakes of A1 Cooling to re-duck the AC system in the Sanctuary to cut down on the noise level when the unit running. The cost will be \$5,000. Motion carried.

Jim Sabo, representing the Personnel Committee, made a motion to establish the position of part-time Children's Ministry with a job description to be prepared along with an application form to be developed in accordance of the hiring policy. This person will work with preschool – 6<sup>th</sup> grade. Sam Graham made a motion to table this until next month. Second by Adam Bland. Motion carried.

The Financial Advisory Committee will add the salary to the budget. This proposal will be placed in the bulletin and announced from the pulpit.
