



Monthly Business Meeting

The Regular Monthly Business Meeting was held at 6:30 p.m. Bro. Billy Compton served as moderator.

Bro. Billy Compton called the meeting to order.

The minutes stood approved as read.

The Treasurer's Report was approved as read by Andrea Morrison. She noted proceeds from our insurance company in the amount of \$73,120.24 for the new roof.

Committee/Department Reports:

Sunday School: Josh Veatch reported a 96 average for October.

Music: The Christmas musical will be presented Sunday night, Dec. 4th, with 18 participating in the choir. The choir will sing on Nov. 20th and a meal will be held after church that Sunday morning.

Trustees: Nothing to report.

Transportation: Sam Graham reported the bus to ready for use.

Security: Sam Graham reported the team is monitoring three entrances with the move to the Fellowship Hall during renovation. They are planning a Christmas party at Wanda's Barn on December 2, 2022. They are appreciative of all the support from the church.

Children's Ministry: Tiffany Benningfield reported she and Josh Veatch are researching curriculum to use and plan to start in January.

Deacons: Larry Bright reported six deacons and the pastor were present for the Nov 2 meeting. They have one recommendation.

Renovation: Don Veatch reported the focus is on the sanctuary right now with the wiring for video and audio being installed, along with new pew upholstery. Our roofer, Terry Gootee, has made a generous \$6,000 donation. With his donation, and the insurance payment, the church cost for roof replacement on the church, fellowship hall, and parsonage was approximately \$3,900.

Youth: Cameron Edwards meets with the group during Sunday School and on Sunday nights.

W.M.U.: The Lottie Moon emphasis is "Reaching the Nations Together." Our goal is \$3,500.

The Cemetery Committee was given permission to follow up with the purchase with an estimated cost of \$137.14 for 1 small sign, 35" x 24", two larger signs measuring 44" x 30" at a cost of \$197.84 each, posts at \$20 each (6 needed) and installation cost of \$150 for a

total package of an estimated \$800. Josh Veatch made a motion for Becky Short and the Cemetery Committee to work on the project. Second by Sam Graham. Motion carried.

Mark Carney assumed the position of moderator.

Bro. Billy Compton, representing the Benevolence Committee, reported on a special need of community member, Michelle Davis. She recently lost her home to a fire, and she and her daughter are in need of a 30-gallon water heater and carbon monoxide detector. Faye Porter made a motion we purchase the needed items at an approximate cost of \$400. Second by Shirley Farmer. Motion carried.
