Committee/Department Reports:

Music: Kathy Snow reported nineteen participated in the Christmas Cantata. The choir will resume practicing on January 15th.

Trustees: Nothing to report.

Transportation: Sam Graham reported checking the bus on Monday, and it is ready for any group to use.

Security: Sam Graham reported they are providing security during worship services and that doorbells have been installed. The Security Office is presently under renovation. They enjoyed a fun-filled party and meal on Dec 2 with Wanda Buckler hosting.

Children: Tiffany Underwood reported there will be a Children's Christmas Party this Friday from 6:00 – 9:00 p.m.

The new curriculum chosen is Orange.

They are creating a rotation team of nursery workers. There will be a T.V. installed that will live-stream the service.

Renovation: Don Veatch reported the Sanctuary flooring has been installed along with painting. Work is being done to fix cracks in the drywall in ceiling of Fellowship Hall. The audio/video is 90-95% complete. Work continues on the upstairs restrooms. While we plan to return to the Sanctuary for services in mid-January, it will not be complete, with wood work/trim still to be installed.

Deacons: Adam Bland reported all the deacons were present for the meeting. Bro. Billy was absent due to sickness. They have no recommendations.

Stephen Carney, representing the Stewardship Committee, presented and made a motion we accept the Proposed Budget for 2023, with total budgeted expenditures of \$251,057.93. This budget calls for an average weekly collection of \$4,828.04. This is an approximate increase of \$15,000 over the 2022 budget. Motion carried.

Josh Veatch made a motion an Internet Service Ad hoc Committee be formed to investigate ways that we can update our technology for wireless internet. Those who have agreed to serve are Kaylene Poff, Cameron Edwards, Mike Peterson, Eddie Snow, and Josh Veatch. Second by Sam Graham. Motion carried.

Bro. Billy Compton made a motion that we have another Tent Revival starting on Back to Church Sunday, Sept 17 and continue through Wed, the 20th. Second by Josh Veatch. Motion carried.

Josh Veatch made a motion that the church purchase a custom-built desk, to be built by B.J. Buckler, at a cost of \$1,200 for the Security Office. This amount will be covered by using \$100 from the Safety and Security Fund and the remainder will be from the General Fund. Second by Sam Graham. Motion carried.
